Description

The Department of Philosophy and Cultural Heritage at Università Ca' Foscari Venezia invites applications for a fellowship financed by the Project CAPIENS - Cosmopolitan Academics, Pluralist Institutions, and the emergence of the New Sciences (ID MSCA_000039) CUP H73C22001360001, Dr. David Malcolm McOmish, and by the project FBC.MRG2023.daRIC-aRICbase.OMODEO, in:

Title: Water Cultures in learned, Commercial and Cosmopolitan contexts

Abstract: The CAPIENS project aims to provide an account of the distinctive nature of scientific culture in the cosmopolitan contexts of Britain, France, the Holy Roman Empire and the Republic of Venice. In these places there existed a number of institutions and centres in which a closely knit group of academics from different national and confessional backgrounds gathered and worked. These institutions had a relative degree of autonomy from the respective orthodoxies prevailing in their territories, attracting itinerant and 'cosmopolitan' scholars. This project will provide an account of a series of geographically broad developments in a variety of emerging scientific disciplines, paying attention to multi-confessional and multi-national aspects. A recurring theme across the above centres is the role of therapeutic water cultures in both Galenic and Paracelsian medicine in a variety of academic and commercial contexts. Several key manuscripts written by members of this network in Paris, Helmstedt, Padua, Edinburgh, Montpellier, Pisa and Basel have been identified (ranging from the notebooks of university students to professional manuscripts by those educated within the traditions) that directly illuminate the educational context of this meeting point of divergent medical practices and water culture. The successful candidate will transcribe, critically examine, evaluate, and digitally archive (Nodegoat and Transkribus) these texts.

The research may be carried out in English.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Università Ca' Foscari Venezia.

Who can apply

Prospective candidates are expected to hold a PhD in History of Science, or related disciplines.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar.

Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months, approximately starting: March 1st, 2025

Stipend: The research fellowship amounts to 28.535,00 Euros per year, including taxes and social charges.

Deadline for submission of applications: January 10th 2025 at 12.00 noon (Rome CET). How to apply:

Candidates shall submit:

- 1. The application form;
- 2. A motivation letter (max 1 page) along with their CV in European format, duly dated and signed, both to enclosed as a one single.pdf file (link); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;
- 3. The attachments called "obligations and understanding" and "participation and compatibility";
- 4. A copy of a valid identity document (either Identity Card or Passport);
- 5. (If available) Evaluation Summary Reports of Marie Skłodowska Curie Actions Individual Fellowships/ ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) individual proposals having passed all the evaluation thresholds;
- (If available) Details of Marie Skłodowska Curie Actions Individual Fellowships, ERC Starting Grants, FIRB (Italian Fund for basic research investments)/ SIR Scientific Young Independence Research funded projects;

- 8. The possession of a PhD, with the date on which it was obtained and the University where the course was held. Candidates must also submit a copy of the foreign title with a translation in Italian or English language including marks obtained, accompanied by a self-declaration relating to the conformity to the original of the translation itself;
- 9. Declaration to fulfil the additional evaluation criteria listed in art. 5 according the scheme "preferential criteria";
- 10. A list of the candidate's scientific publications;
- 11. All documents, qualifications and publications relevant for the selection procedure (please, see the notice <u>link</u>).

Evaluation

Up to 100 points, specifically: For qualifications and publications, from 0 to 60; For the interview, from 0 to 40.

Selection procedure

Short-listed candidates will be invited for the interview on **February 3rd 2025 at 10:00 a.m. (Rome CET)** via **Google Meet.**

The interview will be held in English and in remote only. Further details on how to connect online will be published alongside the convocation notice.
