The evaluation of the scientific and professional qualifications will be in conformity with the requirements deemed necessary for carrying out the research activities.

The Selection Committee can assign a maximum **grade up to 100 points** for the evaluation of the scientific and professional qualifications and CV.

The Commission decides to specify the evaluation grid for titles, CV, other documents produced by the applicants, as follows:

<b>Entry Requirements (max 25 points)</b>	The Examination Board decides to assess the coherence of the training with the profile sought by analysing the CV proposed by the candidate about the degree held and any further qualifications obtained (Italian Law's classes: Economics (L-33) or Economics and Business Management (L-18) or equivalent degree obtained abroad):

<b>Required skills (max 55 points)</b>	<p>The Examination Board shall decide to assess the skills, expertise, and competencies based on the information contained in the CV proposed by the candidate and in the attached documentation. In particular, it shall assign:</p> <ul style="list-style-type: none"> <li>- <b>Max 20 points:</b> for very good knowledge of Python and R;</li> <li>- <b>Max 15 points:</b> for proven data management skills;</li> <li>- <b>Max 10 points:</b> address of the degree course (completed or in progress) relating to business analytics;</li> <li>- <b>Max 10 points:</b> for professional experience in fields related to the research grant (data analytics, social media).</li> </ul>
<b>Any evaluable titles (max 20 points)</b>	<p>The Examination Board shall decide to assess the skills, expertise, and competencies based on the information contained in the CV proposed by the candidate and in the attached documentation. In particular, it shall assign:</p> <ul style="list-style-type: none"> <li>- <b>Max 10 points:</b> for courses or other training in data analytics and machine learning;</li> <li>- <b>Max 10 points:</b> for short-term professional experiences in data/ business analytics.</li> </ul>

<b>MINIMUM THRESHOLD FOR OVERALL ELIGIBILITY</b>	<b>70</b>
