CALL FOR APPLICATIONS

"Venice Summer School (and Workshop) on Inequality and Vulnerability"

Venice, July 6th – 11th, 2026

1. Description

The Department of Economics, within the project VIVA (*Venice Initiative on Vulnerability Analysis*), is organizing the **Summer School and (Workshop) on inequality and vulnerability**. The Summer School will take place on July 6th-9th, 2026 at San Giobbe Economics Campus (Ca' Foscari University of Venice), and will be followed by a workshop on July 10th, 11th, 2026. There is no participation fee.

2. Admission requirements

The Summer School is open to a *maximum of 25 participants*.

The target of students will be PhD students, postdoctoral researchers, and early-career scholars with a background relevant to the themes of the School.

There is no participation fee, but attendees will need to cover their own travel and accommodation expenses (contact details for accommodation will be provided by the Department of Economics).

3. Applications

Deadline for application is the 30th of April 2026 at 12.00 (CEST). Applications must be submitted by e-mail to progetto.viva@unive.it.

The application must include the following documents:

- Application form ([Link](#));
- Dated and signed Curriculum vitae (maximum 2 pages);
- Motivation letter (maximum 1 page);
- Scanned copy of a valid ID document.

4. Evaluation Committee and selection of applicants

An evaluation Committee will be appointed through a Director's Decree and will evaluate the candidates on the basis of their CV and motivation letters.

The committee evaluates the coherence between their academic/research background and motivation and the activities of the Summer School.

The committee will define the evaluation criteria, the scoring rules and will define a ranking list in order of decreasing scores of each candidate.

5. Ranking list

Selected candidates will have to confirm their participation via e-mail and to formalize their registration by the 30th of May 2026.

6. Processing and protection of personal data
