### Description

The Venice School of Management - Ca' Foscari University of Venice, as specified in the introduction, hereby calls for applications for no. 1 Short-term Research Fellowship entitled "*Governance Models and Artificial Intelligence in Port Logistics: A Scientific Framework for the Maritime Ecosystems of the Upper Adriatic*", within the framework of AI-PORT-GOV Project, lasting 12 months – CUP H73C26001000005 – Tutor prof. Raffaele Pesenti.



*The research fellow must perform the following research:*

#### **ABSTRACT:**

*The digital transition is transforming port systems, changing not only the physical flows of goods but also the management paradigms of maritime institutions. The introduction of Artificial Intelligence (AI) into the supply chain raises complex theoretical questions concerning the evolution of organisations, the knowledge economy and the economic-political geography of coastal territories. The AI-PORT-GOV project is primarily a scientific research initiative aimed at investigating the global state of the art of AI applied to logistics, defining at the conceptual and methodological level the new role that a Port System Authority can play in this scenario. The research will map global dynamics and then analyse them in the context of the Veneto region, focusing on the Venice–Chioggia node, and will outline the scientific steps and timelines required for a medium-sized port to align with international standards and position itself at the forefront of the European landscape. The research fellow will work within the Centre for the Study of the Sea, Port-City and Blue Economies (CESMAP), collaborating with all the members of the Centre from a multidisciplinary perspective; they will carry out literature reviews, collect empirical data in the Veneto and Upper Adriatic context, and constantly liaise with the technical structures of the North Adriatic Sea Port Authority (AdSP) for the analysis of the relevant issues, the support of interactions with other economic entities of the macro-regional territory and the validation of the proposed models.*

#### **OBJECTIVES:**

- *Mapping the state of the art of the international scientific literature and global best practices on the use of AI in logistics nodes, identifying which processes can and cannot be automated, the geopolitical biases embedded in modern Large Language Models and the training models required for operators to use these tools consciously (WP1 – months 1-4);*
- *Empirical analysis of the Veneto regional logistics model and of the specific features of the port of Venice (intermodality, environmental constraints, productive fabric), the technological absorption potential of the system, the traceability and explainability requirements of process automation, the comparison between local and cloud-based AI models, system reliability and the role of the human operator in managing AI “hallucinations” (WP2 – months 5-7);*
- *Assessment of the use of AI in regional logistics nodes, evaluating logistics complementarities and possible synergies capable of generating added value (WP3 – months 8-9);*
- *Definition of an evolutionary roadmap and development of an operational prototype of an AI agent for reporting, empirically evaluating the performance differences between cloud-based and local models, the use of RAG (Retrieval-Augmented Generation) architectures with vector database interfaces and the interface with port systems, under appropriate human supervision (WP4 – months 10-12).*

#### **EXPECTED RESULTS:**

- *Report on the international state of the art of AI applied to port logistics and theoretical framing of the new role of Port System Authorities;*
- *Empirical analysis of the Veneto logistics model and of the Venetian specificity, with an assessment of the technological absorption potential of the Upper Adriatic system;*
- *Evolutionary roadmap for positioning the Venice and Chioggia port relative to international and European standards;*
- *Organisation of a final workshop with public bodies, companies, universities and territorial stakeholders to present the main findings of the study;*
- *6 bimonthly reports and a final report on the research carried out, as well as possible scientific publications on the project topics.*

The research fellow must provide the School with the following research output:

- **two-monthly reports** on the activities (Tot. **6 reports**);
- **a final report** on the activities undertaken, highlighting the results achieved.



This documentation is by way of example and not exhaustive and may change or be implemented according to the needs of the research activity concerning the project and/or the structure that calls for the research grant. For anything not specified in this Call, please refer to the Regulations and applicable legislation.

**Duration of the Short-term Research Fellowship: 12 (twelve) months, indicatively starting in November 2026.**

**Amount: The amount of the Short-term Research Fellowship is equal to € 29.953,92 (twenty-nine thousand nine hundred and fifty-three/92 euros) gross percipient and will be subject to taxation according to the regulations in force.** It will be paid in **bimonthly instalments**, after certification of the regular performance of the activity. The amount awarded is understood to include any costs relating to the undertaking of the research envisaged by the project.

**The monthly amount shall only be approved and awarded for whole months completed; amounts for months not completed shall not be awarded.**

**Deadline for submission of applications: not later than noon time (12:00 Rome CET) of Tuesday 13 October 2026.**

In case the deadline is on Saturdays, Sundays or on holidays, it is extended to the first working day thereafter.

**Who can apply? (University Regulation for short-term research fellowships, Art. 3)**

**Applications are open to all EU citizens and non-EU citizens who hold:**

- **Master's degree (Laurea Magistrale or equivalent qualification) in the managerial, economic, computer science or management engineering fields or equivalent foreign qualification.** Qualifications obtained abroad will be examined by the Committee, which may consider them as being equivalent for the purposes of admission, without prejudice to the current legislation.

**In addition, the following skills, competencies and qualifications will be assessed as rewarding:**

**Skills required:**

- **Knowledge of the Italian language at least at C1 level (or equivalent);**
- Knowledge of the English language at least at B2 level (or equivalent);
- Methodological skills in logistics and transport management, industrial economics;
- Research activity and professional experience relevant to the topics of the call.

**Any other evaluable qualifications:**

- PhD in the managerial, economic, computer science or management engineering fields;
- Scientific publications in fields relevant to the topics of managerial, economic, computer science or management engineering.

Those who have a degree of kinship or affinity, up to and including the fourth degree, with any professor belonging to the Department or facility issuing the call, or with the Rector, the General Manager or a member of the University Board of Directors, cannot participate in the selection.

Applicants must hold all the requisites within the call deadline.

Candidates are admitted to the selection conditionally; they may be excluded from the call at any time should they fail to meet the predefined requirements, even after the selection process is complete, with just cause and notification sent to the person concerned.



**Incompatibility** (University Regulation for short-term research fellowships, Art. 12)

The Short-term Research Fellowship may not overlap with:

- other short-term research fellowships granted in any capacity, apart from those granted by national or foreign research institutes in order to integrate with periods abroad the specific activity foreseen by the work plan of the appointed fellow;
- attendance of PhD courses with scholarship and medical specialization, in Italy and abroad;
- research grants “*assegni di ricerca*” o “*incarichi di ricerca*”.

Short-term Research Fellowship holders may carry out self-employed work or occasional or permanent collaborations, as long as this is coherent with the ongoing research, upon approval and on the condition that:

- does not involve a conflict of interest with the specific research activity carried out;
- does not prejudice the university, in relation to the activities carried out.

Subordinate employment contracts holders, in addition to obtaining permission by the University, must provide the authorization of their employer.

- In the specific case that the subordinate employment contract started prior to the awarding of the fellowship, compatibility with the existing employment will have to be assessed; if the assessment yields a negative result, the Short-term Research Fellowship will not be awarded; in the case of a positive result, the successful candidate will have to provide the authorization of his/her employer **within 15 days**.
- In the event that the subordinate employment contract will start once the fellowship is ongoing, the successful applicant is required to notify this change at least 30 days before the start of the employment contract for an assessment of compatibility; if the assessment is negative, the fellowship will cease by the start of the employment contract; in the event of a positive outcome, the successful applicant must provide the authorization of his/her employer **within 15 days**.

**The awarding of the Short-term Research Fellowship does not imply the establishment of any employment contract, nor does it give rise to any rights of access to positions of employment at the university.**

**How to apply** (University Regulations for short-term research fellowships, Art. 5)

**Candidates must submit:**

a) **The application form.**

Applicants must declare in the application, under their own responsibility:

- **the possession of a Master's degree or equivalent qualification obtained abroad.**  
**IMPORTANT: Candidates in possession of a qualification obtained abroad must also submit a copy of the foreign title with a translation in Italian or English language including marks obtained, accompanied by a self-declaration relating to the conformity to the original of the translation itself.** The candidate who has been awarded a **Diploma Supplement**, may not submit any other documentation, provided that the DS provides a complete description of the nature, level, academic system and status of the studies carried out. In any case, it is advised to submit any other document useful to the evaluation of the academic title obtained;
- nationality (the possession of a residence permit valid at the deadline of the call for applications, in case he/she is a non-European citizen residing in Italy);
- to be medically fit to discharge his/her duties for the fellowship;
- that they understand that the Short-term Research Fellowship is not compatible with the positions referred to in Art. 12 of the Regulations for Short-term Research Fellowships and current legislation;
- not to have received measures restricting personal freedom at the time of submitting the application;
- not to have a degree of kinship or affinity, up to and including the fourth degree, with any



professor belonging to the department or facility issuing the call or with the Rector, the General Manager or a member of the University Board of Directors and that they are aware of the provisions of the Law no 240/2010, Art. 18, para. 1, letter b);

- any benefit under L. 104/92.

b) A **CV in European format** (Europass) **duly dated and signed**. The CV must specify the educational qualification held by the candidate and a detailed description of his/her scientific-professional qualifications. In addition, **the CV must contain the following declarations:**

**1) the declaration made pursuant to the Italian D.P.R. 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth;**

**2) the authorization for the processing of personal data for the purposes related to this selection procedure, made pursuant to Legislative Decree no. 196/2003 and Article 13 of the GDPR (EU Regulation 2016/679).**

c) A copy of a valid **identity document** (e.g. Identity Card or Passport);

d) All documents, qualifications and publications relevant for the selection procedure.

The declarations contained in the application form and in the relevant attachments are to be considered for all legal purposes as self-certification pursuant to articles 46 and 47 of Presidential Decree 445/2000 and subsequent amendments and additions of the data contained therein and the attached documents.

The University carries out sample checks on the truthfulness of what is declared, reserving the right to request the originals of the publications.

The untruthfulness of what is declared entails the forfeiture of any benefits resulting from the measure issued, without prejudice to the provisions of the penal code and special laws on the matter.

**The mandatory deadline for submitting applications is set for Tuesday 13 October 2026 at 12:00 (Italian time).**

The candidate, after the uploading, will receive a submission number and an e-mail acknowledging receipt of their application. The candidate if necessary, could access the procedures for updating any data and materials through the link and submission number provided in the e-mail **until the call deadline expires**.

Please note that the University can be contacted for any support needs by the candidate until 24 hours prior to the deadline. For further information please contact Research Area of Venice School of Management – e-mail: [ricerca.management@unive.it](mailto:ricerca.management@unive.it)

Please note that in case of a high number of applications and / or weight of the materials loaded by the candidates the system might become slower. Therefore, it is suggested not to start the process close to the deadline.

Incomplete applications, those without the required data and the compulsory attachments will not be taken into consideration. Furthermore, the applications which, for any reason, reach this University beyond the deadline indicated above cannot be accepted.

The declarations made in the application shall be considered issued in accordance with the DPR no. 445/2000 and subsequent amendments, by candidates entitled to use the simplified administrative certifications permitted by the above decree.



### Selection and Evaluation Procedure

A Selection Committee is appointed by order of the Director of the School taking into account, where possible, gender balance.

The selection is made by **assessment of the scientific-professional qualifications of the candidates, followed by an interview, to be held via teleconference.**

The interviews phase is scheduled for **Tuesday 27 October and/or Wednesday 28 October 2026, via GMEET platform.**

**The short list of candidates admitted to the interview and eventual postponements will be published online on Thursday 22 October 2026** on the VSM website [unive.it/management-ricerca](http://unive.it/management-ricerca) > “Research>Short-term research fellowships>Research fellowships expired calls” and on the University website “Research>Working in research>Short Term Research Fellowships>Research fellowships expired calls”. The publication of the aforementioned calendar, list and announcements have the value of notification; therefore, candidates are required to present themselves, with the valid identification document presented during the application phase, on the day, the time and according to the electronic media indicated in the public notice. The absence of a candidate from the interview will be considered to all intents and purposes as a waiver.

**Please note that proficiency in Italian and English languages will be assessed by the selection committee during the interview of admitted candidates.**

The Commission compiles a ranking and specifies the winning applicant, having regard to the score appointed to experience and qualifications, interview and any other test, as specified by the call. In the event of two or more candidates obtaining the same score at the end of the selection, the younger candidate will be preferred.

### Awarding of the Short Research Fellowship

Having received the selection documents and at the outcome of the checks, the Director approves, by decree, the ranking list and the selection procedure reports and makes them public.

Notification, including the start date of the Short-term Research Fellowship, shall be sent to the winning candidate.

**The winner must accept the Short-term Research Fellowship within seven days of receipt of the written notification referred to above, under penalty of revocation. In the event of withdrawal, the Short-term Research Fellowship shall be awarded to the next available candidate, following the order of the final ranking of merit.**

Publication of the results of all the selection phases shall be published in the online University's notice Board - Albo online, on the VSM website [unive.it/management-ricerca](http://unive.it/management-ricerca) > “Research>Short-term research fellowships” and on the University website “Research>Working in research>Short Term Research Fellowships”.

All information on the convocation of candidates will be published there, too, without further direct communication to the candidates.

Access to the selection documents is guaranteed pursuant to the law of 07/08/1990, no. 241 and subsequent amendments and additions and relative internal implementation regulation.

The Department reserves the right to cancel the procedure and/or not to proceed with the stipulation of the “Declaration of Acceptance” of the Short-term Research Fellowship with the winning person, if for any reason the interest in the research ceases.

## **INFORMATION ON PERSONAL DATA PROCESSING** **pursuant to Article 13 of Regulation (EU) 2016/679**

The Ca' Foscari University of Venice, as part of its institutional aims and in fulfillment of the obligations set forth in art. 13 of the 2016/679 EU Regulation ("Regulation"), provides you with information regarding the processing of personal data that you have provided to the University for the purpose of carrying out the selection procedure you wish to participate in.

### **1) THE DATA PROCESSOR**

### **3) PERSONAL DATA CATEGORIES, PURPOSES AND LEGAL BASIS OF DATA PROCESSING**

The data processing in question involves the provision of personal data and data relating to previous study and professional experience.

Unless the selection procedure is for protected categories, it is not necessary to provide data of a sensitive nature (for example, data concerning health status, sexual orientation or political or trade union opinions); candidates are therefore requested not to provide such data, unless deemed necessary for optimal evaluation of the position selection procedure.

The processing of personal data is aimed solely at the completion of the selection procedure and will take place in a way and within the limits necessary to pursue the aforementioned purpose. The legal basis for this treatment is represented by art. 6.1.e) of the Regulations ("execution of a task of public interest or connected to the exercise of public powers").
