# ABSTRACT

The Covid19 pandemic has hit Italian and Croatian tourism hard and highlighted the sector's weaknesses, including environmental and social sustainability, labor market imbalance and excessive dependence on seasonal tourist flows. Enogastronomy can play a key role in increasing the resilience and competitiveness of the tourism sector, reducing its social and environmental impact, and improving the quality of life of local communities. The TESTEAT project aims to enhance the role of food and wine heritage to promote sustainable socio-economic and cultural development of the cross-border area. The project will give shape to an innovative and integrated cross-border tourist offer through the joint



valorisation of the Italian and Croatian food and wine heritage. In the broader framework of the project, the short-term fellowship research grant will be used for an analysis of the dimensions that characterize the food and wine offer of a tourist destination and for data collection aimed at mapping the situation of the city of Venice. The analysis of the data collected must allow to highlight strengths and weaknesses and outline possible solutions, in order to enhance and, at the same time, make the city's food and wine heritage more sustainable.

#### **OBJECTIVES**

The aim of the research are:

the definition of the key dimensions linked to the food and wine offer of a tourist destination and the link of these dimensions with elements of sustainability;

the mapping of the food and wine offer of the city of Venice;

the SWOT analysis of the city's food and wine offer, thanks to secondary sources and the creation of in-depth interviews with sector operators.

#### **EXPECTED RESULTS**

The research grant involves the execution of the following activities:

- analysis of the literature relating to the following subjects: enogastronomy, key elements of the offer of a tourist destination and sustainability of the tourist offer;
- analysis of the food and wine offer of the city of Venice through:
- a) desk analysis of the available information related to typical dishes, catering and changes in the city's offer;
- b) qualitative analysis through in-depth interviews with the main market operators, using the research protocol developed in collaboration with the TESTEAT project partners;
  - support for the creation of dissemination, discussion and debate events with the main stakeholders in the area.
     The results of these activities will support the research team in achieving the objectives of the TESTEAT project.

Short-term research fellowship: Junior Project researcher 2 – "Food and wine as a distinctive element of tourism offerings. An analysis of the tourist-consumer"

#### **ABSTRACT**

The Covid19 pandemic has hit Italian and Croatian tourism hard and highlighted the sector's weaknesses, including environmental and social sustainability, labor market imbalance and excessive dependence on seasonal tourist flows. Enogastronomy can play a key role in increasing the resilience and competitiveness of the tourism sector, reducing its social and environmental impact and improving the quality of life of local communities. The TESTEAT project aims to enhance the role of food and wine heritage to promote sustainable socio-economic and cultural development of the cross-border area. The project will give shape to an innovative and integrated cross-border tourist offer through the joint valorisation of the Italian and Croatian food and wine heritage. In the broader framework of the project, The research grant will be allocated to an activity of analysis of consumer preferences in relation to food choices, with particular reference to consumption outside the home and to the analysis of the tourist in order to identify how the enogastronomy component affects the choice of destinations and visiting behaviour.

# **OBJECTIVES**

The aim of the research is:

- the analysis of consumption preferences in relation to food and wine and the role of these products in the choice of tourist destination and in tourist behaviour;
- the analysis of the needs and choices of the consumer/tourist in relation to the enogastronomy proposals.

## **EXPECTED RESULTS**

The research grant involves the execution of the following activities:

- analysis of the literature relating to food choice behaviours and to food and wine as drivers of destination choice:
- development and administration of two questionnaires to two samples of consumers/tourists in collaboration with the TESTEAT project partners
- analysis of the data collected and the comparison of the results with those of the other project partners;
- support for the creation of dissemination, discussion and debate events with the main stakeholders in the area.

The results of these activities will support the research team in achieving the objectives of the TESTEAT project.



The scientific coordinator of the project and tutor of the short-term research fellowship is prof. Francesca Checchinato. The research fellow is required to provide the Department with the following documentation:

- Bi-monthly Reports;
- Six-monthly Reports;
- **Final Report**, by the end of the fellowship, which has to be approved by the professor, tutor of the fellowship and will be submitted for examination to the Council of the Department.

The above-mentioned documentation is merely an example and is not exhaustive since it may be subject to change based on the requests of the financing Programme.

<u>Duration of the short-term research fellowship:</u> 12 (twelve) months, each profile is expected to start from June/July 2024 approximately.

<u>Amount:</u> the total amount of each short-term research fellowship is of 19.367,00 euro (euro nineteen and three hundred sixty-seven thousand//00), gross to the recipient, net of the expenses to be sustained by the employer.

The amount, paid in deferred bimonthly instalments, is to be considered inclusive of any costs linked to carrying out the research activity envisaged by the project. The monthly compensation will be recognized and paid only if the activity is carried out for the entire monthly, otherwise the compensation relating to the uncompleted part of the month will not be paid.

<u>Deadline for submission of applications</u>: 24<sup>th</sup> of May 2024, 12 noon (Italian time)
In case the deadline is on Saturdays, Sundays or on holidays, it is extended to the first working day thereafter.

Who can apply (according to art. 3 of the University regulations for awarding short-term research fellowships)

Citizens belonging to European Union member states and non-community citizens in possession of the **following qualifications** may take part in the selection procedure:

Master's degree, or equivalent title according to the Italian law, or equivalent qualification obtained abroad. A Master's Degree in Management (LM-77), Statistical Sciences (LM-82), Sociology and social research (LM-77) will be considered a preferred qualification).

Qualifications obtained abroad will be examined by the Committee, in accordance with article 4, which may consider them as being equivalent for the purposes of admission, without prejudice to the current legislation.

# Required skills:

- good knowledge of English (level A2);
- documented research activities and/or professional experience relevant to the subjects of the call;

#### Qualifications that can be assessed:

- PhD in business economics, statistics and social sciences;
- Master's or training courses relating to the subjects of the call;
- scientific publications;
- previous research activities relating to the subjects of the call.

Those who have a degree of kinship or affinity, up to and including the fourth degree, with any professor belonging to the department or facility issuing the call, or with the Rector, the General Manager or a member of the University Board of Directors, are not eligible for fellowships and are therefore **automatically excluded from participation in the selection procedure**.

Candidates must be in possession of the requirements at the deadline established by this selection procedure announcement.



Candidates are admitted to the selection conditionally; the University will exclude, by motivated provision, candidates who are lacking the prescribed requirements. Said provision is notified to the concerned party at any moment, even after the selection procedure.

Incompatibility (according to art. 12 of the University regulations for awarding short-term research fellowships)

The research fellowship is not compatible with:

- a) other scholarships granted in any capacity, apart from those granted by national or foreign research institutes in order to integrate with periods abroad the specific activity foreseen by the work plan of the appointed fellow;
- b) attendance of PhD courses with scholarship and medical specialization, in Italy and abroad;
- c) research grants "assegni di ricerca"
- d) subordinate employment relationships.

Fellowship researchers can carry out occasional work activities, upon written communication to the scientific tutor and on the condition that:

- a) this activity is declared by the person in charge to be compatible with the pursuit of the research activity referred to in the scholarship;
- b) does not involve a conflict of interest with the specific research activity carried out;
- c) does not prejudice the university, in relation to the activities carried out.

The awarding of the short-term research fellowship does not imply the establishment of any employment contract, nor does it give rise to any rights of access to positions of employment at the University.

How to apply: (according to art. 5 of the University regulations for awarding short-term research fellowships)

Candidates should submit:

a) the attached application form, duly dated and signed. The application form is available on the Department web site (link) and on the University website (link).

In the application form, the candidate must declare:

- the possession of a master's degree or equivalent title obtained abroad;
- nationality (the possession of a residence permit valid at the deadline of the call for applications, in case he/she is a non-European citizen residing in Italy);
- to be medically fit to discharge his/her duties for the fellowship;
- to be aware that awarding of the fellowship is not compatible with the positions referred to in art. 12 of the Regulations on University research fellowships awarding and the current legislation;
- to have/have not criminal conviction and/or being/not being currently involved in criminal proceedings.
   On this regard, the University reserves the right to assess at its discretion, for the purposes of the possible exclusion of the candidate from the selection, the seriousness of the criminal convictions declared and those that may occur as a result of the ongoing criminal proceedings;
- not to have any degree of kinship or affinity, up to and including the fourth degree, with a professor belonging to the department or to the facility issuing the call for applications, or with the Rector, the Director-General or a member of the University Board of Directors (according to art. 18 c. 1 letter b) law n. 240/2010;
- if, in accordance with the law of February 5th 1992 no. 104 and subsequent amendments and additions, shall make a specific request concerning any aids they require in order to take any tests and sit the interview.
- b) their curriculum vitae in European format available online at this *link*;, <u>duly dated and signed</u>, The CV must, specify the educational qualification possessed for the purposes of the application and a detailed description of the candidate's scientific-professional qualifications; <u>a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover, the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and the EU Regulation 2016/679;</u>
- c) a scanned copy of a valid identification document (ID or passport);
- d) any other relevant document, qualification or publication.



The declarations made in the application shall be considered issued in accordance with the DPR no. 445/2000 and subsequent amendments, by candidates entitled to use the simplified administrative certifications permitted by the above decree.

#### Incomplete or incorrect applications with reference to points a), b), and c) will be rejected.

The University performs sample checks on the truthfulness of the declarations made by the candidates in the applications and in the curriculum.

If the above check reveals that the content of the declaration is not true, the Declarant will forfeit any benefits conferred on the basis of the untruthful declaration, without prejudice to the provisions of the criminal code and relevant special legislation.

# Selection Committee and assessment procedure

A Selection Committee is appointed in accordance with art. 7 of the Regulations, taking into account, whereas possible, gender balance. The selection is made by assessment of the scientific and professional qualifications, the curriculum vitae and scientific production of the candidates, followed by an interview.

The interview will be held on June 3rd 2024 by Google Meet.

The list of candidates admitted to the interview, the date, time of the interview will be published online **on May 29<sup>th</sup> 2024** on the following web page of the Department "Ricerca > Bandi Borse di Ricerca' https://www.unive.it/data/17431/, on the University website https://www.unive.it/data/12122/ and on the University registry online http://www.unive.it/data/30402/.

Publication of the above calendar constitutes notification to all intents and purposes of the call for applications. Shortlisted candidates are therefore required to connect, with the identification document presented at the time of submission, on the day and at the time specified in the public notice.

Absence of the candidates at the interview will be considered to all intents and purposes as a withdrawal from the selection, whatever the cause.

The Selection Committee:

I.can award a total of 100 points, to be allocated according to qualifications and interview;



II.on the basis of the scores given, the Selection Committee shall define a final ranking of merit;

III.names the winner. If the event of a tie, priority shall be granted to the younger of the two candidates.

In the event of withdrawal of the winner, the short-term research fellowship shall be awarded to the next available candidate, following the order of the final ranking of merit, according to art. 8 of the University regulations for awarding short-term research fellowships)

The Selection Committee shall submit a selection report to the Director of the Department, who, after verifying the legitimacy of the records, shall approve them and award the short-term research fellowship.

## Publication of the selection documents and awarding of the short-term research fellowship

Having received the selection documents, the Director of the Department approves, by his own decree, the ranking list and the selection procedure reports and makes them public.

The Research Sector of the Management Department will send a written communication to the research fellowship to the each winner of the selection procedure the starting date of the respective short-term research fellowship.

The latter must accept the award within 7 days from receipt of the above-mentioned communication. If not, the short-term research fellowship will be awarded to the next candidate of the ranking list.

Publication of the results of all the selection phases is ensured in the University Registry (Albo online di Ateneo, link) on the University website (*link*) and on the Department web page (*link*) as established by the current regulations.

Access to the selection documents is guaranteed pursuant to the law no. 241 of August 7th 1990, and subsequent amendments and additions and relative internal implementation regulation.

The Department reserves the right to cancel the procedure and/or not to proceed with the stipulation of the Acceptance of the short-term research fellowship with the winning person, if for any reason the interest in the research ceases.
