Research fellowship on "Women's Oratory in the Roman world (8th BCE – 1st CE): comprehensive analysis of the case studies; data processing into the digital platform" - Università Ca' Foscari Venezia (Italian law 30 December 2010, n. 240, art. 22)

Description

The Department of Humanities at Ca' Foscari University of Venice (Dipartimento di Studi Umanistici dell'Università Ca' Foscari Venezia) invites applications for a fellowship in: "Women's Oratory in the Roman world (8th BCE – 1st CE): comprehensive analysis of the case studies; data processing into the digital platform", Academic discipline: L-ANT/03 Roman History, duration 12 months, tutor Prof. Francesca Rohr, financed by SPIN 2023 project "Women's Oratory in the Roman world: the gender Dimension in ancient Speeches (8th BCE – 1st CE), acronym "WORDS", CUP: H73C23000910005, Principal Investigator Prof. Francesca Rohr.

Abstract: The project sets out to investigate the political speeches attributed to Roman matrons between the monarchic and early imperial periods. It focuses on a communication practice from which the mos maiorum excluded women: indeed, by tradition, they did not participate in the institutional life and, therefore, political communication. The research assistants will be expected to conduct a census and systematic examination of literary and historiographic through paper and digital archives, using keywords, to identify case studies and classify them, by an open access digital platform, based on indicators related to the historical reconstruction - female protagonists, contexts, goals, results, judgement on such female behaviour, women's political language - and to the historiographical representation of the phenomenon - narrative format, lexicon/vocabulary.

The fellowship is intended to provide the successful candidate with the opportunity to pursue his/her own research while benefiting from the range of expertise at Ca' Foscari University of Venice.

Who can apply

Prospective candidates are expected to hold a PhD in one of the following fields: Ancient History, Ancient Heritage Studies or other related areas, and should have a suitable scientific / professional track record.

Ca' Foscari encourages applications from researchers with positive evaluation in all the criteria in individual proposals such as Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar. Researchers having successfully completed Marie Skłodowska Curie Actions - Individual Fellowships/ERC Starting Grants/FIRB (Italian Fund for basic research investments)/SIR (Scientific Young Independence Research) or similar funded projects are warmly encouraged to apply.

Duration of contract: 12 months (approximately starting: 1st July 2024)

Stipend: The research fellowship amounts to 19.367,00 Euros, including taxes and social charges.

Deadline for submission of applications: 24th May 2024, h. 12.00 noon (Italian time).

one single pdf file (<u>link</u>); a declaration must be appended in the footnote of the curriculum, pursuant to the Italian DPR 445/2000 and subsequent amendments and additions, that the information provided corresponds to the truth. Moreover, the candidates have to consent to the use of their personal data for the purposes of this selection procedure pursuant to the Italian Legislative Decree 196/2003 and to the EU Regulations 2016/679;

Evaluation

Up to 100 points, specifically: For qualifications, publications and possible tests, from 0 to 60; For interview, from 0 to 40.

The following qualifications are considered as evaluation criteria:

a) Specialization diplomas and certificates of attendance of post-graduate specialization courses, obtained both in Italy and abroad, carrying out of documented research activities at public and private entities with

contracts, research grants, scholarships or assignments both in Italy and abroad;

- b) Participation as a speaker at scientific conferences congruent with the subject area and research topics;
- c) List of publications, with a detail of publications congruent with the topics of the scientific research (at least 1 monograph);
- d) Attached 'preferential securities', if the candidate possesses them see Article 5 of the competition available in Italian (link):
- e) Any other element provided for the announcement, to the articles 2, 3 and 5 of the competition available in Italian (link).

The interview aims to assess the candidates' skills and expertise on the following subjects:

- Knowledge about political communication in the Roman World, proven by the organization of conferences, meetings and seminars at Italian and foreign Institutions, scientific publications, and scintific research on the topic;
- Knowledge about historical and historiographical research on the Roman world;
- Knowledge of English language.

At the end of his/her research activity, the research fellow is required to provide the Department with:

Comprehensive analysis of the case studies; data processing into the digital platform.
